Ft. Hood, Texas. Ms. Priori has conducted over 1,300 forensic exams and trains prosecutors and SANE examiners nationwide.

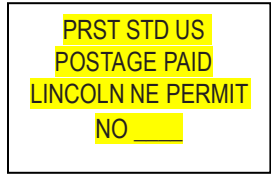
